The Epic Alaskan Adventure:

Explore Glacier Bay & Lake Clark National Parks

Part 1 - June 7-15, 2024 Part 2 – June 15-20, 2024 14 Days – 13 Nights

Join ODC Network CEO and Naturalist Travis Williams for this all-inclusive 14-day itinerary that begins in Juneau, Alaska. There are two parts to this adventure. You may choose one or both.

Part One: We will explore the glacially scoured fjords of Glacier Bay, the glaciers, and the lands between them. The area is 270 years old and offers you an amazing visual of a rapidly changing geological landscape and the plant and animal succession. This region of the US is not only home to a significant number of glaciers, but also to a multitude of plants, mammals, birds and marine wildlife who flourish in this ancient moss-laden, coastal landscape.



Part Two: We will travel to Lake Clark National Park where

we will stay at Redoubt Mountain Lodge. There we will explore the mountain and coastal region around the shores of Crescent Lake and experience the amazing habitat of the coastal brown bear. Using boats and helicopters, our group will travel the region to see these magnificent creatures up close. Other activities include hiking, kayaking, fishing, photography, and more. When it is time to relax, private chefs and guides will ensure you have the very best experience.

Alaska is a rugged and beautiful state home to a wide variety of ecosystems including coastal shoreline, temperate rainforest, mountains, tundra, and a wide variety of wetlands, ponds, lakes, streams, and rivers. This diverse landscape is a tourist hotspot, drawing visitors from around the world. The ODC team are experienced trip guides and hosts, and Alaska is one of our favorite destinations. You may know people who have traveled to Alaska via cruise ship or traversed the landscape via buses, RVs, or train. While these are some of the more popular ways to see the state, the ODC experience is very different. Join us for this unique and customized adventure that will bring you up-close to what makes Alaska great.

Participants who travel to Alaska with the ODC will experience the state in a way that most people never will. You will be part of a group no larger than 12 people. Cruise ships and other typical Alaskan tours pair you with hundreds, if not thousands of other travelers. We only use private, customized travel services and lodges. Private chefs prepare our meals, and Alaskan guides help deliver unique experiences. We will hike, kayak, and travel by helicopter, small boats, and seaplane to ensure you have the most amazing experience.

This trip is all-inclusive. Your lodging, food, drinks, guides, all transportation in Alaska, along with all experiences and gratuities are included.

TRIP SCHEDULE

PART 1 JUNE 7 - 15, 2024

June 7

Flight to Juneau for an early evening arrival. We'll spend the night in Juneau.

June 8

Transfer flight to Gustavus, Alaska. This short 25 min flight will take us to Gustavus, a small and remote community west of Juneau, nestled in the northern part of the Inside Passage and the home of Glacier Bay National Park. Once in Gustavus a private shuttle will transfer us to our lodging for the evening. Dinner and an optional hike will round out our day.

June 9

In the morning, we will travel to Bartlett Cove at the Glacier Bay National Park headquarters, where we will board the Sea Wolf and begin our week aboard our private Glacier Bay cruise. More about Sea Wolf Adventures

June 10 - 14

We will explore the waters, coastlines, glaciers, and forests of Glacier Bay National Park spending roughly 12 hours each day cruising aboard the Sea Wolf, viewing whales, sea lions, seals, otters, bears, wolves, mountain goats, hundreds of birds and more. Our trip will also include hiking and kayaking in and around six different glaciers. Each day our private chef will prepare gourmet meals. Complimentary beer, wine, and sodas will help kick off daily happy hours. Your guides will teach you all about the region and help you have safe and up-close encounters with Alaskan wilderness.

June 14

The Sea Wolf will return to Bartlett Cove in the afternoon. We will have the opportunity to explore the park headquarters before travelling back to Juneau. Overnight accommodations in Juneau.

June 15

End of Part 1 – if not continuing the trip, travel home.











PART 2 JUNE 15-20, 2024

June 15

For travelers continuing from Part 1: Flight from Juneau to Anchorage. You will have time to explore Anchorage if you desire, or relax at the Courtyard Marriott Anchorage Airport. The hotel is adjacent to Lake Hood where we will depart in the morning (16th) via seaplane for our land-based exploration of Alaska. This will also be where we will meet anyone who would like to explore with us for Part 2 of this Epic Adventure.

June 16

Our flight from Anchorage to Redoubt Mountain Lodge, Lake Clark National Park will be a roughly one-hour seaplane flight. We will depart around 8:00AM from Lake Hood and arrive around 9:00am at the lodge. We will have the next three days to explore this new landscape, which will include bear viewing, kayaking, fishing, paddle boarding, helicopter rides, hiking, and more. June 17-19

During our exploration of Lake Clark National Park, you will have the daily choice to go bear viewing, kayaking, fishing, paddle boarding, take helicopter rides, hike, and more. Meals are provided by a private chef and all experiences will be led by professional guides.

June 19

Return seaplane flight to Anchorage. Once in Anchorage we will again stay at Courtyard by Marriott Anchorage Airport.

June 20

Return flight to Michigan (or your choice of destination).

TERMS AND CONDITIONS – THE EPIC ALASKAN ADVENTURE, JUNE 2024

Trip Price: Trip price is based on double occupancy. Participants who specifically request single accommodations will pay an additional charge, subject to availability, on a trip-by-trip basis. If you are traveling alone and wish to share accommodations, we will try to match you with a roommate.

Deposit and payment: The deposit is non-refundable unless a replacement is found for your registered spot. Funds received by ODC from trip participants are deposited into a trust account and managed in accordance with Michigan Sellers of Travel laws.

Cancellation: There is no refund for payments made. If ODC Explorer Network must cancel a trip, we will issue a full refund of amounts paid to us for the trip. However, we cannot be held responsible for personal expenses incurred in preparation for the trip, such as the cost of non-refundable airline tickets or pre-paid hotel expenses. If a replacement can be found for your registered spot on the trip, a reimbursement will be made less any non-refundable fees incurred by ODC Explorer Network.

Trip Cancellation Insurance: We strongly urge you to obtain trip cancellation insurance so your travel investments are covered in the event that you must cancel the trip for personal or family illness. ODC Explorer Network recommends Travelex for international coverage.

Trip price does not include: airfare, baggage handling, excess baggage charges, passport fees when applicable, personal insurance and trip cancellation insurance, and all items of a personal nature.

KNOW BEFORE YOU GO

Baggage: Specific baggage handling services have not been priced into the trips (and are sometimes unavailable). We strongly advise that you pack adequately but lightly and limit baggage to an amount you can easily handle. Not all accommodations have elevators. ODC Network will share additional information on what to bring and the best way to pack for the trip. If you have questions, you may contact us at any time.

Equipment and Preparedness: Since virtually all of our activities take place "off pavement" you should be prepared to encounter rocky and uneven footing, mud, puddles, and even occasional snow patches. Trail conditions can vary considerably during the course of a trip; some trails are wide, well-built and well-graded, while others may be rough and practically non-existent. For trips with more strenuous options, additional gear recommendations and requirements will be provided.

Fitness Requirements: ODC Explorer Network trips take place in a variety of environments and may include activities from hiking to kayaking. All activities are optional and when possible, multiple options for various fitness abilities will be planned. To participate in longer hikes will require a reasonable amount of fitness, elevation changes and sometimes rocky and uneven paths to negotiate. If in doubt about your general physical fitness, consult your physician.

Included Costs: The costs of all arrangements necessary to support the trip described are built into the trip price unless noted. This includes all lodging (in twin/double rooms with private bathrooms unless otherwise specified), meals as specified in the itinerary, guide services, ground transportation costs, and service charges, taxes, and gratuities for service providers. There are no additional charges for chairlifts, cable cars, ferries, or admissions to national parks and other sites included as part of the trip itineraries.

Accommodations: Accommodations for our trips will vary depending on location and availability; however, we strive for accommodations with en-suite bathrooms whenever available in the area we are visiting.
