THIS ENTITY WAS THE OUTDOOR DISCOVERY CENTER (ODC). NINE YEARS LATER, THE ODC MERGED WITH THE MACATAWA GREENWAY PARTNERSHIP IN AN EFFORT TO LEVERAGE AND EXPAND THEIR MISSIONS.
